The Penn Manor Board of School Directors have extended their program providing for property tax rebates to senior citizens, widows, widowers and disabled persons who meet certain income eligibility guidelines and who are homeowners.

Rebates up to \$650 are available and are based upon total income as listed on form PA-1000 for 2014. Penn Manor rebates are limited to those earning \$15,000 or less as per the chart below.

By implementing the rebate program the board is demonstrating a willingness to help the aforementioned individuals for the 2015-2016 fiscal year.

The district rebate is calculated on the amount of the 2014 (bills issued July 1, 2014) school real estate taxes paid. The deadline to file for the district rebate is June 30, 2016.
