

Penn Manor School District Volunteer Affidavit

Volunteer Verification-Exemption from FBI Federal Criminal History Clearance

The Child Protective Services Law requires all volunteers to complete three clearances, including the FBI Federal Criminal History Clearance. However, the Law includes a limited exception which exempts a prospective volunteer from the FBI clearance if both of the following conditions apply: (1) the prospective volunteer has been a resident of Pennsylvania during the entirety of the previous ten-year period; and (2) the prospective volunteer swears or affirms in writing that he/she is not disqualified from service by reason of criminal history.

If you have lived outside Pennsylvania at any point during the prior ten (10) years, you are not eligible for the exemption and this Verification Form does not apply to you. If properly completed, this Verification Form will excuse eligible volunteers from the FBI Criminal History Clearance.

Please read the statements below and complete the form. If the statements are true and apply to you, please sign and date the Verification at the bottom. If you have any questions about this Verification Form or your eligibility, you must contact the Director of Human Resources before submitting the Form.

I am not disqualified from service as a volunteer as a result of a conviction of one or more of the following offenses listed under Title 18 of the Pennsylvania Crimes Coder (or equivalent crime under the federal laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, The Commonwealth of Puerto Rico or a foreign nation, or under a former law of this commonwealth), or the attempt, solicitation or conspiracy to commit any of these offenses:

- 6. I have not been convicted of a felony drug offense under the act of April 14, 1972 (P.L. 233, No. 64), known as "The Controlled Substance, Drug, Device, and Cosmetic Act," committed within the five-year period immediately preceding verification under this section.
- 7. I have never been named in the statewide database as the perpetrator of a founded report of child abuse committed within the last five (5) years.
- 8. I hereby verify and affirm that I understand that a conviction for any of the offenses outlined above or any similar offense under federal or other state law or former law disqualifies me from approval for service as an unpaid volunteer. I further understand and agree that I have an obligation to submit written to the Superintendent or other designated administrator disclosing any future arrest or conviction for any such offenses, and/or notification that I have been listed as a perpetrator in a founded or indicated report, within 72 hours, of the occurrence of such arrest, conviction, or notification of listing as a perpetrator.

I verify that the facts and statements contained in this Volunteer Affidavit are true and correct to the best of my knowledge, information and belief and that the signature is being made subject to Section 4903(b) of the Crimes Code, 18 Pa. C.S.A., relating to crimes for false sworn statements which is a misdemeanor of the third degree punishable by up to one year imprisonment.
