

August 13, 2001

The regular meeting of the Board of Directors of the Penn Manor School District was held on the above date in the Board Room of the Manor Middle School. The meeting was called to order by the President, Mr. C. Willis Herr, at 8:15 p.m.

The meeting was opened with prayer by Dr. Frerichs and was followed by the salute to the flag.

Mr. Herr announced that the next regularly scheduled meeting of the Board of Directors of the Penn Manor School District will be held on Monday, September 10, 2001, in the Board Room of the Manor Middle School at 8:15 p.m.

Mr. Herr asked if there were any Citizen's Comments. There were none at this time.

Mr. Herr asked if there were any additions or corrections to the Minutes of the July 9, 2001, School Board Meeting. There were none. It was moved by Mrs. Withum and seconded by Mr. Anderson to approve the minutes as printed. This motion was passed by a unanimous voice vote.

Mr. C. Willis Herr administered the oath of office to Mr. H. Thomas Herr who took his place on the board.

Dr. Campbell addressed the board with regard to Charter /Cyber Schools. He said there has been much discussion over the past several months with regard to this topic. Dr. Campbell stated that

there are presently 29,000 students enrolled in cyber schools. Most of the districts with students involved in these cyber schools find that the cyber school is not located in their district and they have not approved it. Dr. Campbell said legislators will be meeting with superintendents and boards in the future to discuss this topic. He said he anticipates a large public meeting for discussion of cyber school legislation. Dr. Campbell said he feels the reality is that public schools fund cyber schools and that they are private institutions. He said cyber schools are the thing of the future and public education will change with learning via the internet being part of the educational process. He said he, however, opposes someone a hundred miles from here billing us for something that we don't know anything about. Dr. Campbell stated that Penn Manor is not going to pay bills received from cyber schools and will allow subsidy to be taken. In fact, he stated, none of the districts in the I.U. are paying any of the bills received from cyber schools. Dr. Campbell said he feels this may be one of the greatest attempts to take money from taxpayers under the guise of providing education.

Dr. Campbell then updated the board with regard to the property at Comet Field. He said the sale of this property has gone from the sale of a commercial entity at an agreed upon price to everybody - Millersville Borough, Lancaster Township, Lancaster Planning Commission, and Millersville University - wanting a piece of the pie. Dr. Campbell then commended Mr. Skrocki for his efforts which successfully resulted in a return of \$1,600,000 for Plancon J projects which had been completed in the past on eight building projects within the district. This money will be added to the fund balance.
