Mrs. Nafziger reported that PMEF awarded 70 scholarships to Penn Manor seniors totaling nearly \$70,000. Ms. Wert reported that the Lancaster County Academy graduated 27 students on June 2. There were 8 Penn Manor students. Dr. Frerichs reported that the Superintendent 20-21 goals were reviewed at the board retreat and the 21-22 goals were set.

Mr. Johnston provided an update on recent developments for the final 2021-2022 budget scheduled for adoption on June 21, 2021.

Dr. Leichliter presented the year-end summary of goals for the 2020-2021 school year and reviewed the new goals for the 2021-2022 school year. Approval for placement of this item on the June 7, 2021 board agenda was approved on a motion by Dr. Frerichs and seconded by Ms. Wert. The
