The Penn Manor Board of School Directors have extended their program providing for property tax rebates to senior citizens, widows, widowers and disabled persons who meet certain income eligibility guidelines and who are homeowners.

Rebates up to \$1000 are available and are based upon total income as listed on form PA-1000 for 2025. Penn Manor rebates are limited to those earning \$42,000 or less as per the chart below.

Total Income	Rebate % Factor
0 to \$5,499	100%
\$5,500 to \$5999	90%
\$6,000 to \$6,499	80%
\$6,500 to \$6,999	70%
\$7,000 to \$7,499	60%
\$7,500 to \$7,999	50%
\$8,000 to \$8,499	40%
\$8,500 to \$8,999	35%
\$9,000 to \$9,999	25%
\$10,000 to \$11,999	20%
\$12,000 to \$24,999	15%
\$25,000 to \$35,000	10%
\$35,001 to \$42,000	5%
\$42,001 or over	Not Eligible

By implementing the rebate program, the board is demonstrating a willingness to help the aforementioned individuals for the 2026-2027 fiscal year.

The district rebate is calculated on the amount of the 2025 (bills issued July 1, 2025) school real estate taxes paid. The deadline to file for the district rebate is June 30, 2027.
